University of Southampton Delhi is the first comprehensive international campus to be established in India. We are a full campus of the University of Southampton, a global Top 100 university and a founding member of the Russell Group, the UK's top tier of elite, research-intensive universities.

We are regulated in India by University Grants Commission (UGC), the national regulator for India's public and private universities.

The University of Southampton Delhi campus will give you a full and distinctive Southampton experience. The campus will offer a wide range of courses across multiple subjects, to reflect our offer across the University.

Accommodation

The accommodation is in a safe and quiet residential gated community, within 6km of the campus and connected by a regular, private shuttle bus. Public transport options are also available. We offer a choice of contemporary single or double occupancy rooms, both including breakfast and evening meals. Male and female rooms are separated within the accommodation building and linked to shared communal areas.

Your safety is a top priority and accommodation and campus security protocols are in place to ensure that you always feel safe and secure.

International experience

We are committed to providing international opportunities where possible. For undergraduates we are aiming to provide the option to study at the University's campuses in the UK or Malaysia during your programme. We place a strong emphasis on employability to equip you with the skills and opportunities for career success. Our employability offer is available throughout your degree programme and beyond – for five years after graduation. We will give you access to opportunities including industry experience, study abroad and premium placement on graduation.

Employability

The University of Southampton has an outstanding reputation for preparing our students for future career success. We are top 15 in the UK for employability* and will ensure our India campus leads on career progression for our students. Employability and experiential learning lie at the core of our offering, starting from your first week of study and continuing beyond graduation. In addition to receiving support from our Delhi campus team, you will have access to online resources, regular workshops, and one-to-one guidance, as well as information, advice, and guidance from qualified careers professionals through our MyCareer platform.

Through our 'Pathway to Careers Success' programme you will receive personalised employability and entrepreneurship support, internships, professional accreditation, and a placement cell to maximise employment upon graduation.

Our e-mentoring scheme will give you access to a global community of 2,500 alumni offering tailored career planning, advice on employability skills, and industry insight. We are developing an India-focused alumni mentoring programme for the Delhi campus.

Our strategic links with multinational and industrial organisations mean that you will engage with employers and explore potential career paths. We are developing strategic partnerships with leading global and national businesses. These will give you internships and placements while studying at the campus, and jobs with these key organisations on graduation.

Skills self assessment and development

Our skills model comprises 14 skills that have been identified by employers, industry partners, and broader research as being sought after and valued by graduate recruiters. All our degree programmes have been mapped against the model. On each of our programmes, you will

be able to see which skills are covered in depth in which modules, and an outline of potential career pathways.

You will be able to reflect on your strengths and plan how to develop the skills aligned to your career aspirations, both within and outside your studies, while at university. Our skills self-assessment pathway will encourage you to explore career ideas, consider your career choices, reflect on skills gained and signpost opportunities for skills development.

You will complete an annual skills self assessment, which will show you the skills desired by employers for your career choice, the skills you are currently developing, and the opportunities available to develop those you may not yet have. In this way you will be better prepared for a graduate recruitment market that places increasing emphasis on skills rather than simply on qualifications.

You will be able to apply, and refine, the skills you are developing and have identified through the internships and placements we will offer to you with leading employers. Most will be in the Delhi area, making them easier for you to access and benefit from.

Jobs after graduation

As a final-year student, and provided minimum requirements are met, you will be offered exclusive access to top employers under our Guaranteed Interview Scheme. We will provide CV reviews and intensive interview coaching support to help you both impress on the scheme, and better market your skills for wider employment opportunities.

You will be matched with a University of Southampton alumni mentor who will be able to help you make connections and navigate your next steps. We run a programme of activities that will help you engage with our alumni community from your final year and beyond. On graduation, you can join our local alumni networks for career support and networking opportunities. You will also become part of a global community of over 220,000 alumni that spans over 180 countries.

SCHOLARSHIPS AND BURSARIES

We offer a range of competitive scholarships and merit bursaries that reward excellence and widen opportunity by offsetting the cost of your studies.

Delhi Presidential Scholarship

A competitive scholarship for undergraduates and postgraduates

In order to recognise academic excellence we offer a Delhi Presidential Scholarship to one undergraduate and one postgraduate student. This scholarship will fully fund the tuition fees for the full length of each successful applicant's studies.

Future Talent Scholarship

A competitive scholarship for undergraduates and postgraduates

We offer a Future Talent Scholarship to up to twelve gifted students, selected across all University of Southampton Delhi programmes. This competitive scholarship will contribute 220,000 INR towards one year of tuition fees at the University for the 2025/2026 academic year.

Future Talent Bursary

A merit bursary for undergraduates

We offer a Future Talent Bursary to financially support undergraduates who would benefit from study at University of Southampton Delhi, but might otherwise struggle to do so without a bursary. The merit bursary will contribute up to 660,000 INR towards one year of tuition fees at the University for the 2025/2026 academic year.

We aim to manage our scholarships and bursaries fairly. We consider a range of criteria, including the academic achievements shown on an application to study in addition to individual scholarship and bursary applications. This information helps us to produce a shortlist of candidates for an award, who will be invited to meet with us to discuss their application. A scholarships panel will make a final decision on scholarship and bursary applications.

HOW TO APPLY

Applications are open for the first intake of students in August 2025.

We advise you to apply as soon as possible to receive a conditional offer based on predicted scores for your chosen programme.

Your application will need to demonstrate that you will make the most of your experience at University of Southampton Delhi. We fully review each application, considering academic grades, personal statements and letters of reference to make this assessment. We deliver our programmes in English, and you will need to have a high level of English language proficiency.

A fully completed application will normally allow us to make a conditional offer to study. In some cases, we may need additional information to understand a specific application fairly, which may require a brief meeting with you. A conditional offer will clearly show the offer conditions that you will need to meet, such as providing final grades, or showing an acceptable test score to meet English language requirements. After we send your conditional offer, you must accept it and, if you have received offers for more than one programme, choose which offer is best for you. You must also make a minimum deposit payment equivalent to 10 per cent of first-year tuition fees in order to secure your place.

We will replace a conditional offer with an unconditional offer once you have met any requirements listed in the offer and we have received your deposit.

PROGRAMMES

Our undergraduate programmes are taught in English and content is equivalent to that delivered on other University of Southampton campuses. Although classed as Bachelor of Science programmes, they are suitable for students with K-12 qualifications who have studied in the arts, commerce or science streams. The globally respected nature of UK-awarded degrees means that the three-year UK bachelor's degree is equivalent to a four-year bachelor's degree awarded from a non-UK institution.

BSc (Hons) Accounting and Finance

Duration: three years full time

This prestigious degree offers flexible and versatile career planning and professional certification. It is mapped to the latest developments in financial reporting, from sustainability reporting through to international reporting standards.

Subject overview

This flexible programme explores the evolution of today's business world, allowing you to deepen your knowledge of contemporary business topics from international banking to marketing and human resources. In addition to gaining a thorough grounding in management and financial accounting theory and practice, you can personalise your programme with a wide range of module choices.

Entry requirements*

- Prior knowledge of accountancy is helpful but not essential

- IB: at least 34 points (including 17 points at Higher level, and 4 points in maths and English at Standard level); or
- + A Levels: AAB, plus GCSE maths (Grade B)

BSc (Hons) Business Management

Duration: three years full time

This cutting-edge programme builds deep expertise in a specific management area, while developing your skills, adaptability and knowledge to navigate complex business environments.

Subject overview

On this programme you will explore diverse management ideas and study how commerce, industry and technology have developed with a broader social and historical context. The programme covers foundational management through specialised modules in accounting and finance, analytics, marketing, and business management disciplines. The interdisciplinary approach will allow you to draw from economics, history and the social sciences, while developing your understanding of management and organisational theory, and business research.

- Standard XII: CISCE and CBSE (at least 78%); plus Standard X maths (75%); or

- IB: at least 34 points (including 17 points at Higher level, and 4 points in maths and English at Standard level); or
- + A Levels: AAB, plus GCSE maths (Grade B)

BSc (Hons) Computer Science

Duration: three years full time

Computer science drives the fundamental technologies of today's connected world, from healthcare to industrial applications, global trade, entertainment and security. Able to model and analyse challenges and provide solutions in every area of our lives, skilled computer scientists are highly sought after.

Subject overview

You will study how to design and build software programs and systems, and learn about the latest advances in areas like machine learning, cyber security and computer vision. Through a mix of theoretical, design and practical subjects, you will be taught basic theory underpinning computer science, the ethical and legal framework in which computer scientists and software engineers work, the practicalities of working with computers, and key techniques and application areas.

Entry requirements*

- + Standard XII: CISCE and CBSE (at least 82% with no less than 85% in maths); or
- + State Boards (at least 87% with no less than 85% in maths); or
- + IB: at least 38 points (including 19 points at Higher level including 6 at Higher Level maths (Analysis and Approaches) or 7 at Higher Level (Applications and Interpretation)); or
- + A Levels: A*AA including maths (Grade A)

BSc (Hons) Economics

Duration: three years full time

This is the degree of choice for careers and higher education focused on finance, management and consulting. It has a real-life orientation and will equip you with deep quantitative knowledge and skills that are in demand by employers.

Subject overview

On this flexible programme, you can shape your studies by choosing optional modules such as international banking, risk management, or public economics. You will apply economic and statistical analysis to a range of policy problems. You will develop critical and evaluative thinking and learn how to use conceptual and analytic tools. You will study how the economy works with experts whose research has influenced international policy.

Entry requirements*

- Standard XII: CISCE or CBSE board, at least 78% with no less than 75% in maths. Students from humanities, commerce or science may apply, with or without economics as a subject. Maths in Grade 12 is a required subject; or
- State Boards (at least 82% with no less than 85% in maths); or
- IB: at least 34 points (including 17 points at Higher level including 5 at Higher Level maths (Analysis and Approaches or Applications and Interpretation); or
- + A Levels: AAB including maths (Grade B)



Our postgraduate master's programmes are taught in English and content is equivalent to that delivered on other University of Southampton campuses. The globally respected nature of UK-awarded degrees means that the one-year UK master's is equivalent to a two-year master's degree awarded from a non-UK institution.

MSc Finance

Duration: one year full time

Develop skills sought by employers in rapidly changing and complex financial environments, and advance your career in industry, government or research. Gain a comprehensive understanding of how markets work and how firms can create value.

Subject overview

This programme has a unique emphasis on quantitative and analytical techniques. You will learn advanced stock market analysis, corporate finance, and portfolio management. You will also have an opportunity to study behavioural finance, allowing you to explore the behavioural biases that can affect financial decision making in uncertain environments. You will learn to use models and formal processes within finance and financial management and undertake independent research.

Typical programme content

- + Introduction to finance
- Advanced corporate finance
- Advanced time series modelling
- + Portfolio theory and asset pricing
- + Quantitative finance
- + Banking, finance and risk dissertation

Entry requirements*

- + Upper second-class degree or international equivalent in a subject which includes quantitative study approved by the University
- + IELTS 6.5 overall with 6.5 in reading and writing, and 6.0 in speaking, and listening

MSc International Management

Duration: one year full time

Gain insights into becoming an effective manager in virtually any discipline across our globalised workplace. Develop your broad knowledge and understanding of organisations, the global context in which they operate, and how they are managed.

Subject overview

On this programme you will learn what makes an effective manager, how organisations operate and are managed, and how to resolve issues through your understanding of management concepts. You will develop a range of transferable attributes including analytical, communication and self-management skills. You will be taught key management theory by our experienced team while developing practical skills in core management functions.

- International marketing

- + Accounting and control
- Risk taking and decision making
- Operations management

Entry requirements*

- + Upper second-class degree or international equivalent. Degrees in business English, applied English, or vocational degrees are not accepted
- + IELTS 6.5 overall with 6.5 in reading and writing, and 6.0 in speaking, and listening
